TOURNAMENT A: "MASTER" Restricted to players with ELO (FSI or FIDE) above 1899.

The tournament is rated by FIDE and FSI – Swiss FIDE system pairing.

Tie break rules: 1) Integral Buchholz, 2) Buchholz cut 1,

3) Average Rating of Opponents (ARO).

9 rounds - Rate of play: 90 minutes for 40 moves + 30 for the rest of the game, with a 30 seconds increment for every move played starting from the move one.

TOURNAMENT B: "Libero and Zora Polojaz 13th Trophy" Restricted to players with ELO (FSI or FIDE) below 2001.

Rated by FIDE and FSI - FIDE swiss pairing system.

Tie-break rules: 1) Integral Buchholz, 2) Buchholz cut 1,

3) Average Rating of Opponents (ARO).

9 rounds. Rate of play: 90 minutes, with a 30 seconds increment for every move played starting from the move one.

RULES OF GAME

1 Italian and foreign players can participate in the tournament. Italian players (regardless of place of residence) must have their FSI or junior FSI card valid for the current year; foreign players must have a FIDE ID. If a player is not included in the FIDE rating system, the Arbiter will assign an initial estimated Elo, based on the available elements.

2. For identification purposes players must show up at the registration desk at least 20 minutes before the start of the first round.

3. Any admission of players in the second round will be accepted with an initial score of zero.

4. The tournament provides for 9 rounds and FIDE Swiss pairing system.

5. Smoking, including electronic cigarettes, is strictly forbidden in the playing venue. During play, players should not hold any electronic communication device able to perform chess analysis. In case a player is found to have brought such a device into the playing venue, the said player shall lose the game. The opponent shall win.

6. Registration implies the acceptance of the Rules contained herein. The organizers are authorized to make any amendments they may deem necessary for the best performance of the event. Participants agree, pursuant to Law 675/96 on data privacy, that information relevant to the tournaments, either personal data or the games or game results, can be processed and circulated.

7. Players who are not at the designated desk within 30 minutes from start of the game will lose the game.

8. Arbiters' decisions are final.

9. For all matters not governed by these Rules, the rules issued by FIDE, FSI and CONI (Italian Olympic Committee) in force at the time of the event shall apply.

10. Please note that in order to collect expenses refunds, recipients must provide their tax code; those under 18 must provide also the declaration of whoever exercises the parental authority. Foreign nationals from countries where there is no tax coding system must provide a personal ID valid for expatriation.
